TOWNSHIP BRIDGE PROGRAM

COUNTY ENGINEERS / SUPERINTENDENT OF HIGHWAYS

Attached is a list of counties with their FY 2025 Township Bridge Program (TBP) allotment of the \$60 million, as authorized by the General Assembly, to be used by the road districts for the construction of bridges.

Public Act 103-0853 amends the Illinois Highway Code (605 ILCS 5/6-901-907). A subsequent Circular Letter will be issued to address policy changes.

Any unused FY2025 TBP funds will lapse four years from the date of this Circular Letter (August 29, 2028). Unused FY 2024 TBP funds will lapse August 22, 2027. Unused FY 2023 TBP funds will lapse September 15, 2026. Unused FY 2022 TBP funds will lapse August 30, 2025. Unused FY 2021 TBP funds will lapse August 31, 2024. The oldest funds should be used first.

Please submit your FY 2025 Township Bridge Program to your district office as directed by your district. Utilize form BLR 09210 for your submittals and provide all information as indicated.
