Funding Opportunities/Announcements

The STP-L call for projects opened on **January 17th** and will close on **March 15th at 5pm.** As before, applications are being entered in eTIP, with supplemental documents that applicants need to upload. The call will fill FFY 2026 and FFY 2027 in our program. Staff held a webinar on January 6th but if you were unable to attend and need assistance, please reach out to Heidi Lichtenberger or Troy Simpson. This topic will be covered in more detail later on this agenda.

2023 Highway Safety Notice of Funding Opportunities

The IDOT Bureau of Safety Programs and Engineering (BSPE) has posted **six** Highway Safety Program Notice of Funding Opportunities (NOFOs) for the grant year of October 1, 2022 - September 30, 2023. Illinois is seeking grant applications to reduce serious injuries and fatalities on Illinois roadways. More information can be found [here](#). The grants cover topics such as non-enforcement safety programs, motorcycle awareness, and pedestrian and bicycle safety.

What does the \$1.2 trillion infrastructure plan mean for northeastern Illinois?

The Infrastructure Investment and Jobs Act (IIJA), a \$1.2 trillion infrastructure plan, makes generational investments for rebuilding the nation's roads, bridges, and rails. More than \$567 billion of funding will go toward projects and programs that affect every aspect of transportation. The IIJA increases funding for all four of [CMAP's regional formula programs](#).

- CMAQ (Congestion Mitigation and Air Quality) funds will increase by 10%, from \$2.5 billion annually to \$2.745 billion by 2026.
- STBG (Surface Transportation Block Grant) will increase by 32%, from \$11.3 billion annually to nearly \$15 billion by 2026.
- TAP (Transportation Alternatives Program) will see the largest increase of 76%, from \$850 million annually to nearly \$1.5 billion by 2026.
- Metropolitan Planning Program will increase by 32%, from \$358 million annually to nearly \$472 million by 2026.

Infrastructure Law Implementation Begins

KKCOM TPC Meeting January 20, 2022 Approved Minutes

The U.S. Department of Transportation has launched a new [website](#) for transportation agencies, communities, and stakeholders interested in learning more about the Infrastructure Investment and Jobs Act (IIJA). As part of implementing IIJA, the department is seeking input on the roll-out of new programs and funding. The [first opportunity for input](#) focuses on how the department can best implement highway formula programs continued by the IIJA. The [second](#) is directed at the new formula and competitive funding opportunities for electric vehicle charging infrastructure. CMAP is continually monitoring implementation of the IIJA to ensure northeastern Illinois is taking full advantage of funding opportunities.

Why Oregon is using a Per-Mile Charge to Help Pay for Roads

For decades, motor fuel taxes were used to maintain infrastructure. With cars becoming more fuel efficient, and more people switching to electric and hybrid vehicles, revenue from motor fuel taxes isn't keeping pace with infrastructure costs. Illinois and other states have been at a crossroads over how to fully fund the transportation system in recent years. Under a road usage charge, people pay based on how many miles they drive. The idea is gaining momentum nationally. The newly signed [\\$1.2 trillion federal infrastructure bill](#) includes \$125 million to fund road-usage-charge pilot programs, including the first national pilot. The state of Oregon introduced [OReGO](#), a pay-per-mile program for personal vehicles in 2015. Volunteers who enroll in OReGO install a device in their car that tracks mileage and pay 1.8 cents for every mile they drive. They receive a credit for state fuel taxes, and those with electric or fuel-efficient vehicles are not required to pay a surcharge on their annual vehicle registration fees. In a 2016 [public opinion survey](#), most Oregonians said a road usage charge is a fairer way of funding transportation than other traditional means, such as implementing a vehicle sales tax or increasing vehicle registration fees and motor fuel taxes.

Electric Vehicle (EV) Charging Infrastructure Strategy

CMAP is currently researching the feasibility for an electric vehicle infrastructure strategy. CMAP will be assessing the current state of EV charging infrastructure, gaps in the network, and exploring considerations for equity, efficiency, partnerships, and coordinated investment. CMAP would like to hear from transportation implementers about current work they are pursuing and their thoughts on the region's EV charging needs. Regional Safety Action Agenda

CMAP is continuing its work to improve safety and address the growing number of fatalities and injuries. The Safety Resource Group met for the third time in October to discuss recommendations related to speed management through design, policy, education and enforcement. Topics included ways to improve design to support lower speeds, appropriate speed limits in urban environments, effective and equitable enforcement strategies and how to improve safety data for our region. The discussion points are being incorporated into the speed management paper which is in production. The Resource Group will next meet early this spring. Staff began work on a Bicycle and Pedestrian Safety position paper in early December. The Regional Speed Data project will begin this spring, which will analyze speed probe data to understand patterns of speeding and target countermeasures. An [update](#) on the group's work was presented at the July 16, 2021, CMAP Transportation Committee.

New Planning Projects Help Communities Achieve Regional Goals

More than 20 communities throughout northeastern Illinois will receive new planning assistance from CMAP to help them prosper in the years ahead. CMAP approved 21 new [technical assistance program](#) projects following a joint call for projects earlier in the fall with the RTA. CMAP staff will work to strengthen resiliency, prioritize investment and support inclusive development – regional principals identified in [ON TO 2050](#), the region's long-range plan. Burlington in Kane County will work with CMAP staff on taking next steps to implement ideas that can improve quality of life, transportation and land-use decisions.

Kane County Bike Plan Update

KDOT is receiving UWP funding for SFY 2023 to update the Kane County Bike Ped Plan, previously updated in

2012. QBS advertising will begin soon targeting a June 30, 2023 completion date. Those interested should attend the KKCOM Bike Ped Committee meetings going forward. The next meeting is **February 17th at 2 PM.**

Fox Valley Bike Share

The Fox Valley Bike Share closed out the 2021 operating year with system revenues at \$2,472.43 and system rides at 608. This is a near doubling of activity over 2020, which for the same monthly period saw system revenue at \$1,293.41 and system rides at 225. Council staff are preparing to release an MOU for participation in the development of a new RFP in 2022.

B. CMAP Report

Kama Dobbs gave updates on behalf of CMAP. She noted that the office is now open daily, with staff working on a hybrid work schedule. She noted that committee meetings are still being held virtually, and that CMAP has launched Legistar for committee meetings.

Marilyn Solomon gave an update on local projects in IDOT District 1.

B. Current FY22-25 STP Active and Contingency Programs

Heidi Lichtenberger presented the FY22-25 STP-L Active and Contingency Programs for adoption. The STP-L FY22-25 Active and Contingency Programs were posted for an e-mail vote and were adopted unanimously following the meeting.

C. KKCOM FY23-27 STP-L Call for Projects

Troy Simpson presented the application materials for the upcoming FY23-27 Call for STP-L Projects. Ken Jay inquired about the prioritization of existing projects requesting increases versus new project applicants in the upcoming fiscal years. Troy Simpson responded that cost increases for existing projects would not be considered in the new program years until after the new projects have been slotted into their awarded years. Jackie Forbes reminded project sponsors of contingency program projects that they must re-apply in order to be considered from Federal Fiscal Year 2023 and onward. Scott Marquardt asked about the accuracy of the projected increases in Surface Transportation Program funds. Troy Simpson explained that the projected funds were based on a nationwide increase of 36%, but would be adjusted as the allocation to the Illinois Department of Transportation and its sub-allocations to the Metropolitan Planning Organizations are finalized.

Jennifer Hughes mentioned that ROW acquisition has begun for the Village of Oswego's Wolf's Crossing project.

\$2.9 billion in IIJA funding available for major projects

The U.S. Department of Transportation announced that [\\$2.9 billion in grant funding](#) is available for major infrastructure projects under the IIJA. State, regional, and local governments will be able to use a single application to pursue grant funding through three separate programs either established or reauthorized by the infrastructure law. Applications are due by **Monday, May 23**.

FY2024 Local Highway Safety Improvement Program

Kane County Bike Plan Update

KDOT received three responses from Civiltech, Jacobs and Epstein in March, and now QBS has closed and Epstein of Chicago, Illinois has been selected along with their sub-consultant, WSP to update the Bicycle and Pedestrian Plan for the region. The initial cost proposal is being reviewed and once approved will be set for May County Board approval. Work for the plan is set to begin on **July 1st**.

Fox Valley Bike Share

KDOT is gearing up to post the revised RFP for bike share services in the Fox Valley. The revisions will incorporate input from participant communities which were convened in 2021 to discuss performance of the current vendor, Koloni. The RFP will be targeting a late April posting.

Regional Safety Action Agenda

CMAP is continuing its work to improve traffic safety and address the growing number of fatalities and injuries. Staff is wrapping up a policy paper on speed management and continuing work on a bicycle and pedestrian safety policy paper. Our Safety Resource Group met for the third time in October to discuss the initial recommendations for speed management and will convene again this spring to discuss implementation steps and initial bicycle and pedestrian safety recommendations. Three LTA safety projects are in progress in Calumet City, Bellwood and Riverdale to address multimodal traffic safety at intersections and along corridors. The Regional Speed Data project will begin this spring, which will analyze speed probe data to understand patterns of speeding and target countermeasures. An update on the group's work was presented at the January 25, 2022 Council of Mayors [meeting](#).

Funding Opportunities/Announcements

Safe Streets and Roads For All (SS4A) Discretionary Grant Program

Under the [Bipartisan Infrastructure Law \(BIL\)](#), the USDOT announced that the [\(SS4A\) Program](#) is a \$1 Billion Program for FFY 2022 which is targeted to assist with ensuring safe streets and roads for all, and to address the national roadway safety crisis. [The Notice of Funding Opportunity \(NOFO\)](#) and [additional resources](#) can be found in [Circular Letter 2022-14](#). Applications from eligible entities must be submitted by **September 15**.

Rail Grade Crossing Safety Program – Federal Section 130 Funds

The Illinois Department of Transportation is accepting applications for the [Highway Grade Crossing Safety Program](#) for FY2023 and FY2024. This program aims to improve safety at local agency railroad/highway crossings by installing new warning devices, upgrading existing warning devices, incentives for voluntary closures, and other related rail/highway safety improvements. Due to the Bipartisan Infrastructure Law (BIL), the Section 130 program now includes an increase of the federal share to 100 percent. Applications are

due **October 4**. Please review the [Notice of Funding Opportunity \(NOFO\)](#) for more information.

U.S. DOT Reconnecting Communities Pilot Program - Planning and Capital Construction Grants

The [Reconnecting Communities Pilot \(RCP\) discretionary grant program](#) is the first-ever program to help reconnect communities previously cut off from opportunities by transportation infrastructure through solutions like high-quality public transportation, infrastructure removal, and main street revitalization. Visit the [RCP Program website](#) to access the [NOFO](#). Applications are due **October 13**.

Bridge Investment Program

FHWA is accepting applications for the [Bridge Investment Program](#), which helps replace, rehabilitate, and preserve the nation's bridges. More than \$2.4 billion in grant funding is available for federal fiscal year 2022. The program also expands the list of eligible applicants to include all levels of government. Applications for large bridge projects (eligible costs more than \$100 million) are due Tuesday, **August 9**. Applications for smaller projects (less than \$100 million) are due Thursday, **September 8**.

Illinois Transportation Enhancement Program (ITEP) Cycle 15

The [Illinois Transportation Enhancement Program \(ITEP\)](#) will open the solicitation for Cycle 15 beginning August 1 and will end September 30. This cycle will provide \$125 million in state and federal funding for walking, biking, and trail projects around the state. Active Transportation Alliance and Illinois Public Health Institute will hold a 3-part Webinar Series to introduce the ITEP program and recent changes, prepare applicants for the application process, and provide guidance on completing the application. State Legislative Updates in Transportation

Immediate GATA Relief as Granted by Public Act 102-1092 (HB 4489)

On June 10th, Governor Pritzker signed [HB4489](#), creating [Public Act 102-1092](#). This Public Act amends the Grant Accountability and Transparency Act (GATA); and provides that the requirements established under the Act do not apply to awards, including capital appropriated funds, made by the Department of Transportation to units of local government for the purposes of transportation projects utilizing State, federal funds, or both State and federal funds. In addition, the Act shall recognize that federal and federal pass-through awards from the Department of Transportation to units of local government are governed by and must comply with specified federal guidelines (2 CFR 200).

Township Bidding Threshold Raised to \$30,000

On May 6th, Governor Pritzker signed [HB4251](#), creating [Public Act 102-728](#). This Public Act raised the threshold at which Townships are required to bid from \$20,000 to \$30,000. The Public Act was effective immediately. Townships are no longer required to bid purchases that are less than \$30,000.

Partner Updates

RTA – Renewing Ride Free Permits

RTA offers special programs for seniors, low-income residents, and people with disabilities. One must apply in order to receive these benefits. IMPORTANT REMINDER: If your RTA Ride Free permit is expiring soon, it's very important to apply or for Benefit Access Program (BAP) as soon as possible. The BAP eligibility period is two years, so most applicants need to reapply at this time. Apply for BAP at the [Illinois Department of Aging's website](#) or call 1-800-252-8966 [TTY: 1-888-206-1327].

Metra Super Saver Pass

Metra is now offering a \$100 "Super Saver" monthly pass that allows for unlimited travel anywhere in the system. Discounted passes are available for eligible seniors and K-12 students. Funding Opportunities

U.S. DOT SMART & ATTAIN

The FY2022 **Strengthening Mobility and Revolutionizing Transportation (SMART)** and **Advanced Transportation Technology and Innovation (ATTAIN)** Grants through the U.S. DOT are soliciting applications for two programs that will make \$160M available annually for the next five years for projects that use technology to improve our transportation infrastructure and make communities safer.

- SMART: The program will fund purpose-driven innovation and focus on building data and technology expertise such as:
 - Vehicle automation and connectivity
 - Systems innovation for logistics, traffic signals, smart grid, and data integration, and more. See [NOFO](#) for more info.
- ATTAIN: This program will promote advanced technologies to improve safety and reduce travel times for drivers and transit riders that can serve as national examples. See [NOFO](#) for more info.

U.S. DOT Thriving Communities Program

IDOT Updates

Rebuild Illinois Bond Grants Sixth (6th) and Final Installment

IDOT is providing Local Public Agencies with the sixth (6th) and final installment of the \$1.5B grant program. It consists of \$250M that will be distributed based on the regular Motor Fuel Tax (MFT) formula. Distribution allotments may be viewed [on-line](#) under the tab “REBUILD ILLINOIS”. 2020 Census Population for MFT

IDOT has updated populations to reflect the 2020 Census as certified by the Illinois Secretary of State for Stat Motor Fuel Tax (MFT) allocations to municipalities. The September allotment, disbursed in October, is the first to use the updated populations. As a result of the challenges faced by the U.S. Census Bureau with the 2020 Census, there have been delays with the release of the information typically used by IDOT. The U.S. Census Bureau is still releasing additional data from the 2020 Census and reviewing unexpected census results. If a community identifies an unexpected census result, the community’s officials may consider the [three options presented by the U.S. Census Bureau](#).

NEW! Project Program Information Form

IDOT’s PPI (Project Program Information) form has been updated and is effective September 1, 2022. Please use [this form](#) going forward, any PPI’s submitted on the old form will be returned for revisions.

IDOT Releases FY 2023-2028 Multi-Year Program

On August 12, IDOT released the [FY 2023-2028 Proposed Highway Improvement Program](#), which includes \$34.6 billion to improve roads, bridges, transit, rail, airports, and ports over the next six years. The program aims to improve 2,562 miles of roads and nearly 10 million square feet of bridge deck. This funding represents a robust commitment to invest in people and communities backed by the historic Rebuild Illinois capital program. Read the press release [here](#).

IDOT Accepting Electronic Signatures

On August 19, IDOT issued Circular Letter 2022-21 announcing updates to more than twenty BLRS forms to accommodate the use of electronic signatures. A list of the affected forms and instructions for electronically signing forms is included in the circular letter.
