## FIT FOR KIDS GRANT PROJECT GOALS GRID AND QUESTIONNAIRE

**Project Summary:** (Provide a general statement explaining the problem/opportunity the project will address and identify the benefits of implementing the project)

Children, especially children under age three, who do not get enough nutrients through healthy foods, begin life at a serious disadvantage (Feeding America, n.d.). As these children age, they are more likely to repeat a grade in school, experience developmental impairments, and experience more social and emotional problems. Because nutritious foods tend to be more expensive than unhealthy food, nearly all low-income households report purchasing the cheapest food as opposed to food that is healthy (Feeding America, n.d.). By implementing nutrition education and gardening programs at two early childhood education centers serving low-income children and families, the project will increase awareness of the importance of eating healthy food and provide families with knowledge and skills to obtain and prepare healthy, nutritious meals.

## Target Population of your organization and project

The project will serve children and families enrolled in two Early Head Start – Child Care Partnership (EHS-CCP) centers in Aurora. EHS-CCP is a federally funded program providing comprehensive services to low-income children and families.

#### **Project Questions**

1. Provide a detailed description of your project/program, including the target population and geographic area it will serve.

The project will promote health and nutrition through gardening education and healthy eating experiences for children and families. Because children's preferences develop at a young age, early childhood is the ideal time to establish healthy eating habits. Furthermore, research from the Harvard Graduate School of Education (2006) has found that family engagement, particularly for low-income students, can promote school readiness and improved academic outcomes.

The project will implement a three level approach to delivering nutrition education to children and families enrolled in two early childhood centers in Aurora. The approaches include the following three objectives:

The primary learning tool will be an indoor garden. Children will participate in planting seeds, caring for plants, and tasting food grown in the garden. Each classroom will receive gardening tools and equipment to explore the indoor garden. As children assist in caring for the garden and engage in tasting experiences to introduce new foods, they will develop an understanding of where food comes from and understand the difference between healthy and unhealthy foods. In addition to this hands-on approach, children will also experience the *Harvest For Kids* curriculum. These free curriculum materials will provide teachers the tools they need to educate children about nutrition, healthy eating, and gardening. Classrooms will also receive a supply of nutrition- and gardening-themed books.

In order to provide continuity between home and school, classrooms will receive Nutrition Literacy Kits. These kits, which include nutrition and gardening-themed books along with hands on materials for children to explore, will be sent home with families. As families explore nutrition-related books and materials with their children, children will be able to

connect learning at school to learning at home. These kits will also serve to educate families on the importance of eating healthy foods. To enhance the parent education component of this project, families will also have the opportunity to participate in a Nutrition Workshop. The workshop will provide hands-on learning experiences around cooking healthy foods and the importance of nutrition.

By introducing children to gardening and healthy eating experiences at school and reinforcing these lessons and activities at home, children have a greater likelihood of eating a healthy, nutritious diet. This approach will create sustainable, lasting change for the children and families of Aurora, particularly those surrounding the two early childhood centers. Not only will classrooms have the supplies needed to implement these programs for many years, teachers, children and families will have the knowledge and skills to continue healthy lifestyles in the future.

The project will be implemented in two early childhood education centers currently partnering with YWCA through the Early Head Start – Child Care Partnership (EHS-CCP) program. One center is located in downtown Aurora (Lincoln) and the other is located in the Hometown (Town Center) subdivision. Demographic data of the two center locations is as follows:

For over 140 years, YWCA Metropolitan Chicago has provided important social services to women and their families in the Chicagoland area. For the more than 20 of those years, YWCA has developed deep experience training childcare providers, administering childcare subsidies for health meal preparation, managing an extensive childcare referral program, and providing technical assistance services focusing on health and nutrition. The two proposed locations for implementation are currently partners with the YWCA through the Early Head

Start Child Care Partnership (EHS-CCP) program. As such, these centers receive additional funds and supports to sustain high-quality learning environments for children and generate positive outcomes for families.

Laurin Atkinson, Data and Compliance Coordinator – Early Head Start Child Care Partnerships, will be responsible for administering the project. Laurin has more than 15 years experience in Early Childhood Education and has spent time as a classroom teacher, curriculum coordinator, and Center Director.

Audrey Farace, Child Care Assistance Specialist, will provide training and technical assistance for the project. She has extensive experience in large-scale garden projects and nutrition education through her work with the City of Portland Public School system.

This project is a collaboration with the YWCA Early Head Start – Child Care Partnership (EHS-CCP) program, as the proposed locations are current childcare partners in the EHS-CCP program. Additionally, the project will leverage resources and support from the YWCA's Tummy program, administrator of the Illinois Child and Adult Food Care Program (CACFP).
